Recovery-Oriented Cognitive Therapy: The mission of The Beck Institute Center for Recovery-Oriented Cognitive Therapy (CT-R) is to improve the lives of individuals with serious mental health condition diagnosis, along with their providers and families. The Center enacts research, implementation, and advocacy. All implementations involve focus groups, workshops, and ongoing consultation for a 6 to 9 month period.
